

Annual statement of accounts already circulated. Approved. Proposed Campion Fearmando. Seconded V. Ranganathan.

Comments on the accounts:

Campion Fernando: Accumulated funds remain constant. Should not be the case.

Shehan Fernando: Organise something for everyone at planned events rather than adding more as it may impact participation.

Reyaz Jeffrey: Identify some Sydney based Old Joes who can take part in rugby tournaments. Three rugby players who play cricket and get more involved along with Melbourne players.

Upeka to be sports coordinator rather than just cricket.

Lalith Grero: Perhaps a picnic for younger families Invite everyone to submit ideas for usage of funds with a shorter duration which may have more participation. Please share ideas at the next committee meeting.

> Lalith Grero: Encourage younger Joes to attend through sub-committees.

> George Rupesinghe: A face to face meeting for the next committee gathering.

> Lalith Grero: Feast day Mass 16th of March. Christmas event in the last week of November.

Kevin Pereira: Kids menu at Christmas event to be considered for next year.


